Breakout Session Descriptions

A Table Top Exercise (TTX) of a simulated attack in metropolitan Atlanta will be presented to all summit participants. Each of the breakout sessions below will address a different aspect of the same scenario based upon the theme of the breakout session.

You must attend the workshop to which you have been assigned. The color on your name tag corresponds with the workshop in which you are registered.

<u>Planning and Response: Local and Regional Hospitals</u> Room A402

This session will focus on the impact of a terrorist attack on local, regional and statewide hospitals. Participants are expected to address triage, mobilizing hospitals, setting priorities, and coordination efforts between medical facilities and public safety agencies. Participants will discuss the scenario and offer solutions to questions posed by the facilitators. The breakout recorder/reporter will share the breakout session's results with the plenary audience.

Decontamination Room A403

This session will discuss the response from public safety personnel, businesses and the community with regard to handling hazardous materials. Participants are expected to discuss emergency plans, training for potential threats of man-made and natural disasters, organizational response, and coordination of activities before, during and following the event. Participants will examine the need for and implementation of drills, and how to contain potential "run off" of hazardous materials. Participants will discuss the scenario and offer solutions to questions posed by the facilitators. The breakout recorder/reporter will share the breakout session's results with the plenary audience.

Transportation Room A404

This session will assess considerations of how a complex multi-location terrorist attack can affect transportation in the metro area. Participants will discuss the impact on local business and what businesses need to do to prepare for both natural and man-made events. How will businesses work with public safety organizations to ensure the safety of their employees traveling to and from work? Discuss resiliency and the need to move quickly to recover from the event. Participants will discuss the scenario and offer solutions to questions posed by the facilitators. The breakout recorder/reporter will share the breakout session's results with the plenary audience.

Infrastructure Protection Room A405

This session will discuss the considerations of what businesses and companies can do to mitigate the results of man-made and natural disasters. What can businesses do internally to reduce the impact of a major incident? Participants will discuss the need and importance of partnerships with public safety and other businesses. Participants will discuss the scenario and offer solutions to questions posed by the facilitators. The breakout recorder/reporter will share the breakout session's results with the plenary audience.

CHIEF IOEL BAKER

A native of the city he serves, Joel Baker began his professional fire service career with the City of East Point Fire Department (1986). In 1988, he joined the Atlanta Fire Rescue Department where during his tenure he has held the following positions: Firefighter/Paramedic, Fire Lieutenant in Field Operations and the Atlanta Fire Training Academy, Captain to the department's Hazardous Material/Technical Rescue

Unit, Section Chief – Office of Professional Standards, and Assistant Chief to the Office of Support Services. As Assistant Chief of FY2008, Joel was instrumental in the management of the department's 86 million dollar budget in addition to the development and implementation of the department's budget reduction strategies. In August 2009, he was appointed Interim Fire Chief, making some of AFRD's most crucial decisions in its history as it related to employment reduction, station de-commissioning consideration, and challenged morale.

Joel was later appointed by the Fire Chief as Chief of Staff in June 2010. In this role, he directly managed critical sections such as Assessment and Planning, Capitol Projects, Homeland Security, Office of Professional Standards, and the Public Information Office. This leadership role required coordination with City Council, City of Atlanta Law Department, U.S. Equal Employment Opportunity Commission, local business leaders, and Neighborhood Planning Units.

In July 2012, Joel was reassigned as Deputy Fire Chief of Airport Administration at Hartsfield-Jackson Atlanta International Airport (HJAIA). At what is unequivocally deemed as the "World's Busiest Airport", serving an average of 200,000 passengers daily, Joel was responsible for providing unparalleled Fire Protection, EMS, and other Emergency Services to the HJAIA Community. His division's infrastructure includes 244 Fire Personnel (227 Sworn and 17 Civilian Personnel), 5 Fire Stations, 49 Front Line Response Vehicles (Aircraft and Structural), and 6 Auxiliary Response Vehicles. In December 2014, he transitioned into the role of Interim Fire Chief for Atlanta Fire Rescue and shortly thereafter, appointed by Mayor Kasim Reed as the Fire Chief in June 2015.

Examples of his most highly regarded responsibilities relate to achieving some of AFRD's primary Operations Initiatives. These initiatives will be instrumental in the success of the department both internally and externally. Positioned under three of the six Organizational Priorities (Emergency Preparedness and Response, Customer Service, and PIER - Public Information, Education, and Relations) are the following internal measures: Insurance Service Office Class Rating, Target Hazard Identifica-

tion/Preplanning, the Center for Public Safety Excellence Accreditation, and 2011-2012 Annual Report. Likewise, external measures include: Atlanta Emergency Preparedness Institute, Citizens Fire Academy, Website Enhancements, and Public Service Announcements.

His educational experiences consist of an Associate's of Applied Sciences, in Fire Science Technology (1995), a Bachelor's of Science in Human Resources & Policy Studies from Georgia State University - Andrew Young School of Policy Studies (2006), a Master's of Public Administration Degree (Justice Administration) from Columbus State University (2010), and Harvard University - Senior Executive Education in State and Local Government program (2013). Recognized by the Commission on Professional Credentialing, Joel was awarded his third Chief Fire Officer Designation (CFOD). This certification is received by demonstrating a high level of competence, as witnessed by his peers, documenting professional, educational, technical, and community service achievements and fulfilling prescribed standards of performance, ethics, and conduct. He also received his designation as an Executive Fire Officer (EFO) via the National Fire Academy, Emmitsburg, MD. The Executive Fire Officer Program (EFOP) is an initiative of the United States Fire Administration/National Fire Academy designed to provide senior officers and others in key leadership roles with enhanced executive-level knowledge, skills, and abilities necessary to lead, conduct research, and engage in lifelong learning.

Recognizing the importance of community service and professional organizations, Joel served in many community organizations, as well as being a member to many professional organizations such as: Columbus State University – Georgia Command College Advisory Board Member, Board of Director Member – National Safe Place Network, 100 Black Men of America (Dekalb County, Georgia Chapter), International Association of Fire Chief, Metro Atlanta Fire Chiefs Association, National Society of Executive Fire Officers, and the Society for Human Resource Management.

CHIEF RODNEY BRYANT

Assistant Chief Rodney N. Bryant is an Atlanta native, educated in the Atlanta Public School system. He attended M. Agnes Jones Elementary School and Sylvan Hills High School. Immediately after graduating from high school, Assistant Chief Bryant joined the United States Army Reserves where he became a Combat Medic.

Assistant Chief Bryant has 29 years of service with the Atlanta Police Department. He was appointed to the rank of Assistant Chief on December 28, 2016. In 2015, he was appointed as Deputy Chief and was bestowed command of the Community Services Division.

Assistant Chief Bryant has held additional ranks including Sergeant, Lieutenant and Major, amounting to every rank attainable during his tenure with the Department, save for the position of Police Chief. He has been colored with accolades and honors for the significant achievements he has seen within these capacities, which have lent to the overall productivity and growth of the Atlanta Police Department.

A proponent of scholarship and excellence, Assistant Chief Bryant is notably committed to his craftsmanship and continuously pursues opportunities to enhance his aptitude. Assistant Chief Bryant holds a Bachelor of Science degree in Criminal Justice from Georgia State University. He also possesses a Masters of Science in Administration, earned at Central Michigan University.

Assistant Chief Bryant continues to engage in senior/executive leadership development training, lending to his expertise, generally as a Law Enforcement professional and specifically as a leader of a large police agency. - Event Manager and Commander of Public Safety planning for the impending 2018 College Football Championship Game and 2019 NFL Super Bowl
- Organized by the Georgia International Law Enforcement Exchange, Assistant Chief Bryant along with 16 other senior Georgia public safety officials learned best practices on counter-terrorism measures.

Assistant Chief Bryant enjoys engaging with the community. His favorite part about the job is collaborating with both officers and citizens to solve public safety issues.

Assistant Chief Bryant is the proud father of three daughters and grandfather of one granddaughter. He is also a member of Elizabeth Baptist Church in Atlanta, P.H.A. Masonic Order and the Greek Fraternal Organization Omega Psi Phi Fraternity, Inc.

CRAIG DOWDELL



Craig Dowdell is a 23year veteran of the US Fire Service. He holds a Bachelor of Science Degree in Marketing from Tuskegee University, and holds multiple certifications in the disciplines of Hazardous Materials Technician, NFPA 1006/1670 Compliant Technical Rescue Technician, Georgia Peace Officer (POST) Certified, NPQ Fire Service Instructor and a Georgia POST Instructor. Dowdell is also a licensed State of Georgia Emergency Medical Technician-

Intermediate (EMT-I) and operates as Team Leader for the Atlanta Fire Rescue Department Tactical Medic Team.

Currently, Dowdell is a Lieutenant-Homeland Security Officer for the Atlanta Fire Rescue Department assigned to the Atlanta FBI-Joint Terrorism Task Force assisting the WMD Coordinator. Duties include but not limited to Information Sharing, Special Events Management, conducting Critical Infrastructure Site Assessments, interfacing with all City of Atlanta Stakeholders at the local, state and federal level to include private industry to ensure partner readiness for planning, mitigation, response, and recovery. Dowdell is also an Sports and Special Events Incident Management Adjunct Instructor with the Texas A&M Engineering Extension Service (TEEX). He also holds various certifications in the National Incident Management System (NIMS System) such as I-100 through 400, Planning Section Chief, Resources Unit, Situation Unit Leader, Documentation Unit Leader and Demobilization Unit Leader.



DR. ROBERT FRIEDMANN

Dr. Robert R. Friedmann is director of the Georgia International Law Enforcement Exchange and Professor Emeritus of Criminal Justice at Georgia State University's Andrew Young School of Policy Studies. He was the Distinguished Chair of Public Safety

Partnerships (2007-2010) and served as Chair (1989-2002) of the Criminal Justice Department at Georgia State University. Dr. Friedmann received his B.S. (Sociology and Anthropology, and Philosophy) from the University of Haifa, Israel (1974); his M.A. and Ph.D. (Sociology) from the University of Minnesota (1978); and his M.S.S.W. (Social Work) from the University of Wisconsin-Madison (1981).

His interest and published work focus on community policing, terrorism, and crime analysis. His books include: Community Policing: Comparative Perspectives and Prospects, (1992), Criminal Justice in Israel: An Annotated Bibliography of English Language Publications, 1948-1993 (1995), Crime and Criminal Justice in Israel: Assessing the Knowledge Base toward the Twenty-First Century (1998), A Diary of Four Years of Terrorism and Anti-Semitism: 2000-2004 (2005; two volumes), and 28 Letters (2012). He

authored numerous articles and research reports on crime and criminal justice focusing on policing and public safety. He was the recipient of several federal grants to improve crime data.

Dr. Friedmann chaired the Georgia Commission to Assess State Crime Laboratory Needs into the 21st Century; he is a Member of the Georgia Association of Chiefs of Police (GACP), and a Member of the International Association of Chiefs of Police (IACP) and its Community Policing Committee. He assisted in security planning and preparation for the 1996 Olympic Games in Atlanta, for the 2004 Olympic Games in Athens, Greece, for the 2012 Olympic Games in London, and for the G-8 in Sea Island, Georgia. He served as a member of the Fulton County Court House Security Commission and he serves on the advisory board of the International Institute for Counter-Terrorism, Herzliya, Israel, the Research Institute for European and American Studies, Athens, Greece, and is a member of the executive committee of The International Counter-Terrorism Academic Community.

Dr. Friedmann works closely with a number of police departments, in the U.S. and internationally, on community policing and homeland security.



ASTON T. GREENE, III

A native of New York City, Aston began his professional law enforcement career with the New York State Department of Corrections (1996). In 2002 he joined the DeKalb County Police Department where during his tenure he has held the following positions: Patrol Officer, Master Patrol Officer, Field Training Officer, Gang Investigator Detective, Intelligence Analyst Detective, Homeland Security Detec-

tive, Emergency Manager and Executive Aide to Deputy Chief of Homeland Security/Emergency Management Director. As Aide to the Deputy Chief, he was critical to the establishment of the DeKalb County Emergency Management Agency (DEMA) and implementation of many homeland security initiatives for the county to include successful submission of state grant applications and development of Local Emergency Operation Plans.

Aston is currently serving as the Commander of the Emergency Preparedness Unit (EPU) for the Metropolitan Atlanta Rapid Transit Authority (MARTA), the 9th largest public transportation system in the U.S. With primary duties as an Emergency Manager, Law Enforcement, and Security Expert, Aston works on a variety of high-profile security projects (i.e. vehicle security cameras, CCTV with video analytics, 'See & Say' App, Security Plans, Intelligence Policies, etc.). Further, he manages approximately \$100 million dollars of security related projects in the MARTA 10-Year Capital Improvement Plan (CIP) and is a portfolio manager, program and project manager for various security efforts emanating from the CIP.

and project manager for various security efforts emanating from the CIP. He is also the key point of contact key point of contact for the policy oversight of the U. S. Department of Homeland Security's (DHS) Transit Security Grant Program (TSGP) approving the project proposals and ensuring implementation of DHS goals and objectives. As a Certified Emergency Manager (CEM) for the State of Georgia, Aston manages the MARTA Emergency Operations Center (EOC), Mobile Command Vehicle (MCV) and supervises sworn, civilian and contract employees to achieve the security and emergency preparedness goals of MARTA.

Aston's academic credentials include a B.S. in Criminal Justice and a Master of Public Administration Degree which is undergirded by his extensive project and program management experience in the area of security and emergency management projects with a focus on Crime Prevention through Environmental Design (CPTED) and DHS core capabilities for transit agencies. He is the lead on MARTA's compliance program with the Transit Security Administration (TSA) BASE Assessments and FTA's Security Mandates for Transit (49 CFR pt. 659). Also, as the Executive Director of the MARTA Multi-year Exercise Program, he has become one of the most accomplished Exercise Directors in the State of Georgia. Additionally, Aston is the designated Public Information Officer (PIO) for the MARTA Police Department and has represented MARTA with major media outlets along with local, state, and federal agencies. He has completed the Georgia Institute of Technology Cybersecurity Leadership Program in addition to the Transit Security Administration's Loaned Executive Program where he was deployed to Washington D. C. with secret clearance to represent MARTA for a month of federal policy level interactions.

Recognizing the importance of community, training, and education, Aston established MARTA's first Community Emergency Response Team (CERT) and is a Georgia post certified instructor teaching homeland security incident management to executives, local academies and at the state college level. Aston is a member of the ASIS security professional organization and an associate member of the National Organization of Black Law Enforcement Executives (NOBLE).



Janulyn Lennon became Hartsfield-Jackson's Director of Security in 2011. Hartsfield-Jackson accommodated more than 104 million passengers in 2016 and employed 63,000 workers.

Ms. Lennon leads the team responsible for protecting and managing the Airport security program – a comprehensive security approach that includes risk-

based security, compliance and enforcement, inspections, access control, security services, physical security, contract management, surveillance, smart

Under Ms. Lennon's leadership, the Airport has executed numerous security programs, including enhanced background investigations, perimeter protection and, most recently, a comprehensive employee screening checkpoint. Additionally, Ms. Lennon was charged with implementing a comprehensive human trafficking educational awareness training program at the Airport.

In addition, Ms. Lennon provides security oversight and ensures security considerations are at the forefront of ATLNext, the Airport's new 20-year, multibillion-dollar capital improvement program. ATLNext is designed to boost capacity, renew and replace existing facilities, and enhance ATL's aesthetic appeal. Projects include new cargo warehouse facilities, a sixth runway, four-star hotel, Domestic Terminal modernization, new gates and parking decks.

Ms. Lennon represents Hartsfield-Jackson on the Transportation Security Administration's Aviation Security Advisory Sub-Committee, and she is active in the security practice areas of the American Association of Airport Executives and Airports Council International. In December 2016, Ms. Lennon received her International Airport Professional (IAP) certification after successfully completing the Global Airport Management Professional Accreditation Programme (AMPAP), which promotes professional excellence in airport management.

Ms. Lennon joined the Hartsfield-Jackson team in 2002 following a successful career in corrections, which included a tour of duty as a deputy warden at a regional jail in Virginia. A native of Baltimore and graduate of North Carolina Central and Coppin State universities, Ms. Lennon holds a Bachelor of Arts in criminal justice and a Master of Science in criminal justice/security administration, with summa cum laude honors.

MARY V. LEFTRIDGE-BYRD


In April 2009, Mary V. Leftridge Byrd, began service as the Federal Security Director (FSD), Senior Executive Service, U.S. Department of Homeland Security, Transportation Security Administration, Office of Security Operations, Hartsfield-Jackson Atlanta International Airport Atlanta, GA, the world's busiest airport. With over 30 years' experience as a corrections, public safety and aviation security, Director Leftridge Byrd has established a reputation and

track record of accomplishment in objectives achievement, workforce development, organizational success, with demonstrated expertise in constituency building and meaningful stake holding. Director Leftridge Byrd has been a champion in collaborating with partners in the Atlanta metropolitan area. Director Leftridge Byrd has been instrumental in achieving significant

improvement in counterterrorism and insider threat strategies, risk mitigation, threat detection, passenger, baggage and cargo security operations, and regulatory compliance.

Being consistently engaged, working collaboratively with public and private colleagues has been a hallmark of her career while serving on the local, state and federal levels. In her current position as the senior field executive, she has led the TSA-ATL team in establishing federal security requirements On behalf of the Department, she has overseen the design, construction and opening of two additional passenger screening checkpoints and an inline checked baggage screening system. This resulted in increased daily screening of over 48,000 pieces of checked baggage and 70,000 originating passengers through 55 security screening lanes on six security checkpoints and baggage operations. She was instrumental in operationalizing the first United States based innovation screening technology. She led her team in making operational the \$1.5 billion Maynard Holbrook Jackson International Terminal which opened in May 2012.

DAVID J. LeVALLEY



Mr. LeValley entered on duty as a Special Agent with the FBI in 1996 assigned to the New York Division. He investigated Colombian/Caribbean drug trafficking and money laundering organizations on a task force with the

New York City Police Department. In 2004, Mr. LeValley managed national investigations into major theft syndicates, transnational gangs, and drug trafficking groups in the Criminal Investigative Division at FBI Headquarters. He also led the FBI's Jewelry and Gem Program. In 2007, Mr. LeValley supervised the FBI/MPD Safe Streets Violent Gang Task Force in Washington, D.C. and led investigations and initiatives to reduce gang-related violence in the Nation's capital. He would later lead WFO's Violent Crimes Branch as an Assistant Special Agent in Charge. In 2013, Mr. LeValley served as the Section Chief for the Transnational Organized Crime – Western Hemisphere Section where he provided executive level leadership for international organized crime matters. In June 2015, he was appointed SAC of the Criminal and Cyber Division at WFO.

Mr. LeValley earned a Bachelor of Science degree in Criminal Justice from Shippensburg University of Pennsylvania and a Continuing Education Certificate in Leadership from Georgetown University. Prior to joining the FBI, he served with the United States Marine Corps and as a police officer for the Harrisburg Police Department in Pennsylvania.

Mr. LeValley lives in the metro Atlanta area with his wife. They have three children.

COL. MARK MCDONOUGH



After graduation as the Valedictorian of his high school class at Rabun Gap-Nacoochee School, Mark McDonough received an appointment to the United States Naval Academy at Annapolis. He graduated with a Bachelor of Science degree and was commissioned as a Second Lieutenant in the United States Marine Corps. After attending The Basic School in Quantico, Virginia, he attended flight

school in Pensacola, Florida, and Basic Electronic Warfare and Advanced Electronic Warfare School. In October 1988, he was assigned to VMAQ-2 at MCAS Cherry Point, N.C. as a Naval Flight Officer and deployed in August of 1990 to Bahrain in support of Operation Desert Shield / Desert Storm. McDonough flew 35 combat missions in the EA-6B "Prowler" earning the following awards: Single Mission Air Medal with Combat "V," Air Medal with numeral "3," Navy Commendation Medal with Combat "V," Southwest Asian Service Medal, War Time Service Medal.

McDonough began his career with the Department of Public Safety in 1995 and graduated from the 70th Georgia State Patrol Trooper School. His assignments have included serving as a trooper and Assistant Post Commander at Post 27 Blue Ridge, a pilot in the Aviation Division, Legislative Liaison and Executive Assistant to the Commissioner, Commanding Officer of the Georgia State Patrol, and the Deputy Commissioner of the Department of Public Safety. McDonough has served as the Officer in Charge of the 2007 and 2011 Inauguration Pass-In-Review. He was elected president of his Trooper School class and received the Department's Valor award. McDonough is an FAA Certified Commercial Pilot with Single and Multiengine Land; Instrument Airplane; and Rotorcraft-Helicopter ratings. McDonough currently serves as the Commissioner of the Department of Public Safety and holds the rank of Colonel with the Georgia State Patrol.

As a graduate of the Georgia Law Enforcement Command College, McDonough received his Masters of Public Administration from Columbus State University on May 10, 2008. In December, 2008 McDonough also graduated from the 235th Session of the FBI National Academy at Quantico, Va.
