NICK ANNAN

Nick Annan currently serves as the Special Agent in Charge for Homeland Security Investigations (HSI) in Atlanta, Georgia. Mr. Annan has oversight of the HSI Atlanta area of responsibility, which includes 11 offices in the states of Georgia, North Carolina and South Carolina.

In his current position, Mr. Annan manages all of HSI's complex federal law enforcement investigative programs related to national security and smuggling violations, including counter-proliferation, financial crimes, commercial fraud, human trafficking, human smuggling, narcotics smuggling, transnational gangs, cyber-crimes, child pornography and exploitation, and document and benefit fraud. He has oversight of a diverse cadre of federal agents, intelligence analysts, and professional administrative staff. He also oversees a number of HSI-led multiagency task forces, which include state, local and federal law enforcement members working together to target cross-border criminal organizations that exploit the legitimate travel, commercial trade and financial systems.

Prior to his selection as Special Agent in Charge, Mr. Annan served in a number of field and headquarters leadership positions. Mr. Annan comes to Atlanta from HSI San Diego, where he served as the Deputy SAC with oversight of over 250 law enforcement officers and personnel. In this position, he had oversight of one the largest ICE investigative offices in the nation, which includes both San Diego and Imperial counties.

Mr. Annan recently served 6 months as the acting Director of the Intellectual Property Rights Coordination Center (IPRCC). The IPRCC stands at the forefront of the U.S. Government's response to global intellectual property (IP) theft, enforcement of its international trade laws, and preventing predatory and unfair trade practices that threaten the global economy. The IPR Center brings together 23 partner agencies, consisting of 19 key federal agencies, Interpol, Europol and the governments of Canada and Mexico in a task-force setting.

Mr. Annan has also served as the Chief of Staff to the director of HSI and provided management oversight at the national level. Additionally, he has held the positions of the Deputy Attaché in Rome, Italy, the Assistant SAC in San Diego and the Deputy Chief of Staff for Investigations.

Mr. Annan began his law enforcement career in 1997 as a Special Agent with the U.S. Customs Service in San Diego, CA. Mr. Annan graduated as a Scholar-Athlete award recipient from the University of Maryland where he received a Bachelor of Science degree in Economics.



PATRICK BAILEY

Patrick L. Bailey is the director of the Medical Examiner's Office for DeKalb County. In this position, Mr. Bailey oversees all departmental operations/divisions, including: the Forensic Death Investigation Division, Forensic Pathology Division, which includes the Forensic Laboratory and all personnel.

Mr. Bailey joined DeKalb County in 1996 as a uniform patrolman in the departments Uniform Division Center Precinct. He later transferred Center Precinct's C.O.P.S./COBRA Unit conducting street level investigations into narcotics activity, prostitution and targeted areas of high crime. Mr. Bailey was again promoted to Detective and served initially as a Robbery Detective. After a year, he was transferred to the Homicide Assaults Unit. Upon completing 4 years of service, Mr. Bailey was recommended and accepted a position in the Chief of Police's Office as an Internal Affairs Detective.

The Medical Examiners Office increased staffing and Mr. Bailey was recommended and accepted a position as a Forensic Death Investigator. While serving in the Medical Examiners Office, Mr. Bailey has served in the following capacity:

Mr. Bailey has attained certifications by the Peace Officers Standards and Training (P.O.S.T.), the National Incident Management Systems (N.I.M.S.), Undercover Drug Operations

Patrick Bailey attended Troy State University, earning a Bachelor of Science degree in general business/finance.

Department Summary – Medical Examiner's Department

The medical examiner performs investigations into deaths that are required by law to be reported to the DeKalb County Medical Examiner, and which fall under the jurisdiction of the Georgia Death Investigation Act, O.C.G.A. § 45-16-24. The reporting of death cases as required by this law is done seven days a week, 24 hours a day, weekends and all holidays.

A medical examiner's inquiry is required on all deaths that come within the purview of the law, and this investigation must start immediately. This inquiry may include, but is not limited to, obtaining a detailed history on the decedent and the circumstances surrounding the event, a scene investigation, a scene reconstruction, an external examination, a limited dissection,

an autopsy, a post autopsy investigation including laboratory studies, or any combination thereof. Evidence may be collected at the scene, and the body removed from the location of death to the DeKalb Forensic Science Center/Morgue Facility. Once cause and manner of death is determined, a death certificate is issued.



CHIEF RODNEY BRYANT

Assistant Chief Rodney N. Bryant is an Atlanta native, educated in the Atlanta Public School system. He attended M. Agnes Jones Elementary School and Sylvan Hills High School. Immediately after graduating from high school, Assistant Chief Bryant joined the United States Army Reserves where he became a Combat Medic.

Assistant Chief Bryant has 29 years of service with the Atlanta Police Department. He was appointed to the rank of Assistant Chief on December 28, 2016. In 2015, he was appointed as Deputy Chief and was bestowed command of the Community Services Division.

Assistant Chief Bryant has held additional ranks including Sergeant, Lieutenant and Major, amounting to every rank attainable during his tenure with the Department, save for the position of Police Chief. He has been colored with accolades and honors for the significant achievements he has seen within these capacities, which have lent to the overall productivity and growth of the Atlanta Police Department.

A proponent of scholarship and excellence, Assistant Chief Bryant is notably committed to his craftsmanship and continuously pursues opportunities to enhance his aptitude. Assistant Chief Bryant holds a Bachelor of Science degree in Criminal Justice from Georgia State University. He also possesses a Masters of Science in Administration, earned at Central Michigan University.

Assistant Chief Bryant continues to engage in senior/executive leadership development training, lending to his expertise, generally as a Law Enforcement professional and specifically as a leader of a large police agency. His leadership development accomplishments include, but are not limited to the following:

- 2014 - Completed a two-week public safety program and exchange focused on new public safety techniques and technologies.
- 2015 - Major Cities Chief of Police Executive Leadership Institute.
- 2016 - Atlanta Police Leadership Institute.
- Graduate of the Police Executive Research Forum Senior Management in Policing.

- Event Manager and Commander of Public Safety planning for the impending 2018 College Football Championship Game and 2019 NFL Super Bowl
- Organized by the Georgia International Law Enforcement Exchange, Assistant Chief Bryant along with 16 other senior Georgia public safety officials learned best practices on counter-terrorism measures.

Assistant Chief Bryant enjoys engaging with the community. His favorite part about the job is collaborating with both officers and citizens to solve public safety issues.

Assistant Chief Bryant is the proud father of three daughters and grandfather of one grand-daughter. He is also a member of Elizabeth Baptist Church in Atlanta, P.H.A. Masonic Order and the Greek Fraternal Organization Omega Psi Phi Fraternity, Inc.



HOMER BRYSON

Homer Bryson was appointed Director of the Georgia Emergency Management and Homeland Security Agency by Governor Nathan Deal on December 1, 2016. Prior to this appointment, Bryson served as Commissioner of the Georgia Department of Corrections. Bryson began his career in state government in 1983 as a conservation ranger with the Department of Natural Resources. He continued his DNR career by serving as Colonel of the Law Enforcement section and then Deputy Commissioner before moving to the Department of Corrections.

Director Bryson served as the hurricane coordinator for the Department of Natural Resources while assigned as the DNR Law Enforcement coastal region supervisor. He participated in security planning for the 1996 Olympic Games and the 2004 Group of 8 Economic Summit on Sea Island. He was a supervisor on a 100 officer Georgia state law enforcement detail assigned to assist with recovery efforts in Louisiana after Hurricane Katrina. He has previously taught Critical Incident Management as an adjunct professional for the Georgia Law Enforcement Command College at Columbus State University.

Bryson currently serves on the Georgia State Indemnification Commission and the Peace Officers' Annuity and Benefit Fund. Bryson previously served on the Georgia Board of Public Safety, Georgia Criminal Justice Coordinating Council, Georgia Peace Officer Standards & Training Council, Georgia Behavioral Health Coordinating Council, and as Chairman of the Department of Community Supervision Board. He is a life member and past President of the Peace Officers Association of Georgia.

He earned a bachelor's degree from Valdosta State University and a master's degree in Public Administration from Columbus State University. Bryson and his wife, Lisa, have three children and reside in Nicholson, GA.



RYAN BUCHANAN

Ryan Buchanan is an Assistant United States Attorney at the U.S. Attorney's Office for the Northern District of Georgia and the Deputy Chief of the Violent Crime and National Security Section.

Ryan has served as lead counsel in over 200 prosecutions that have involved over 40 federal crimes. He has prosecuted cases involving violent crimes such as armed robbery, kidnapping, and carjacking; crimes involving the exploitation of children via child pornography production and distribution; and organized crime cases involving national gangs. In addition to managing these matters from their inception through appeal, Ryan has been lead or co-counsel for more than a dozen trials.

Ryan is also one of only a handful of federal prosecutors in the country who have fully prosecuted cases involving the support of foreign terrorist organizations and attempts by would-be domestic terrorists to acquire weapons of mass destruction. Ryan currently serves as the National Security and Anti-Terrorism Coordinator for the Northern District of Georgia. In this role, Ryan works closely with the FBI's Joint Terrorism Task Force and a wide cross-section of federal, state, and local law enforcement, first responders, and private sector security personnel to provide and exchange terrorism-related information regarding threats, criminal enforcement, and intelligence.

Ryan is a graduate of Samford University and Vanderbilt University Law School.



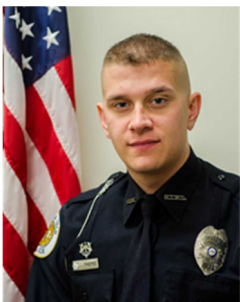
DARRELL CHANEYFIELD

Darrell Chaneyfield has been with the InterContinental Hotels Group since 2002. As the director of security & intelligence he is responsible for protecting the Group's business strategy, brand reputation and assets from security and associated threats, primarily through the development and implementation of security programs, protective security systems, internal investigations, and the direction of regional global intelligence.

Reporting directly to the Vice President of Global Security, Mr. Chaneyfield's responsibilities include: leadership of the Americas & Canada support teams, principal security advisor for America's new products, management for regional security incidents, regional security training programs, direction and co-ordination of the Groups regional intelligence system, regional business intelligence, regional security threat & risk assessment, event security, corporate security crisis coordinator of the emergency issues management team (EIMT), and security subject matter expert (SME) appointed by Legal during depositions.

Prior to joining IHG, Mr. Chaneyfield was an Assistant Special Agent in Charge with the Georgia Bureau of Investigation from 1987 to 2002. In that position, he directly supervised 13 employees from eight jurisdictions and prepared performance management evaluations for state employees. He also supervised covert and overt investigations within three county jurisdictions. Mr. Chaneyfield managed an operational annual budget of approximately \$500,000. He also implemented and reviewed policies and procedures for compliance and changes; managed staff development and training programs; interviewed witnesses and interrogated suspects related to criminal activity; and investigated individuals engaged in violations of state and federal laws.

Mr. Chaneyfield started his law enforcement career with the Smyrna Police Department as a patrolman from 1985-1987. He attended South Carolina State University from 1981-1985 and earned a B.S. in Criminal Justice. He is certified as a Certified Protection Professional, Certified Crime Scene Specialist and as a Peace Officer in the State of Georgia. He has memberships with the American Society for Industrial Security, Association of Certified Fraud Examiners, South Eastern Analyst Roundtable, Atlanta MetroPol Intelligence, American Hotel & Lodging Association Safety & Security Committee, Domestic Security Alliance Council, and Overseas Security Advisory Council United States Department of State.



LORAN CRABTREE

Officer Crabtree started in corporate security / Law Enforcement in 2010 and has served both with the Villa Rica Police Department and the Georgia Institute of Technology Police Department. From 2016-2018 Officer Crabtree went part time at the Police Department and full time with Turner Broadcasting / CNN Global Security as an Investigative Threat Analyst. At Turner Global Security he used social media and open source to analyze different types of threats and provide situational awareness for over 100 brands in 200 countries for over 10,000 employees, as well as being the main liaison with local, state and federal law enforcement and other corporate security.

After gaining valuable experience at Turner Broadcasting Officer Crabtree returned to the Georgia Tech Police Department where he oversees all the department's social media outreach, conducts threat assessments and provides situational awareness to the command staff.

Officer Crabtree is on the board of directors for both the Association of Threat Assessment Professionals (ATAP) Southeast Chapter and the Southern States Police Benevolent Association (SSPBA) State Chapter.



ERIC DE LA BARRE

Eric De La Barre is the Senior Intelligence Specialist currently serving with the Department of Justice, working counter-terrorism for the U.S. Attorney's Office, and attached to the Atlanta FBI Joint Terrorism Task Force as the Counter-Terrorism Working Group Coordinator. De La Barre has more than 39 years of military and civilian experience in multiple disciplines as an Intelligence Professional, with a focus on enemy weapons systems and capabilities, the Middle East, and Terrorism. He holds a Master of Science in Strategic Intelligence from the Joint Military Intelligence College, Bachelor of Science in Government & Politics from the University of Maryland, and an Associates in Applied Science in Intelligence from the Air Force. He is a graduate of the Intelligence Community Advanced Analyst Program.



LT. CRAIG DOWDELL

Craig Dowdell is a 24-year veteran of the US Fire Service holding the rank of Lieutenant with the City of Atlanta Fire Rescue Department Homeland Security Unit. Assigned to the Atlanta FBI-Joint Terrorism Task Force as a Task Force Officer, he assists the WMD Coordinator. Current duties include but are not limited to Intelligence/Information Sharing, Special Events Management, conducting critical infrastructure site assessments, interfacing with all City of Atlanta stakeholders at the local, state and federal level to include private industry to ensure partner readiness for planning, mitigation, response, and recovery. He is also a licensed State of Georgia Emergency Medical Technician-Intermediate (EMT-I) and operates as Team Leader for the Atlanta Fire Rescue Department Tactical Medic Team. He is an Agency Instructor II staff member with the Texas Engineering and Extension Service (TEEX) at Texas A&M University. Lieutenant Dowdell instructs course attendees in Sports and Special Events Incident Management (Management 404) and Enhanced Sports and Special Events Incident Management (Management 440).

Lieutenant Dowdell holds a Bachelor of Science Degree in Marketing from Tuskegee University and is currently pursuing a Master's Degree in Homeland Security from the Naval Postgraduate School. He holds multiple certifications in the disciplines of Hazardous Materials Technician, NFPA 1006/1670 Compliant Technical Rescue Technician, Georgia Peace Officer (POST), NPQ Fire Service Instructor, and Georgia POST Instructor. Other certifications include but are not limited to the National Incident Management System (NIMS System) such as I-100 through 400, Planning Section Chief, Resources Unit, Situation Unit Leader, Documentation Unit Leader, and Demobilization Unit Leader.



DR. JONATHAN EISENSTAT

Dr. Jonathan Eisenstat completed his undergraduate studies at University of California at Davis in 1993 and earned his medical doctorate from Sackler School of Medicine in Tel Aviv, Israel in 1998. After a year and a half of surgical residency, he completed an anatomic pathology residency at The State University of New York at Stony Brook in 2003. Dr. Eisenstat then completed a one year fellowship in Pediatric Pathology at New York Uni-

versity before entering into the Forensic Pathology and Forensic Neuro / Cardiac Pathology fellowships at the Office of Chief Medical Examiner in New York City.

Dr. Eisenstat joined the Georgia Bureau of Investigation in 2006 as an Associate Medical Examiner, became Deputy Chief Medical Examiner in 2014, and was appointed Chief Medical Examiner in November 2015. He has assisted in a number of Metro Atlanta medical examiner offices and is an autopsy consultant with Children's Healthcare of Atlanta. He sits on a number of national, state and local committees.



JOHN M. GARRIGAN

John Garrigan is Senior Vice President of Organizational Development where he is responsible for organizational service excellence, marketing/communications, human resources, employee development/training, strategic account quality assurance and a wide range of other operational, branding and strategic initiatives. John has over 30 years of leadership and operating experience in contract security, corporate security and public safety.

John was formerly with Barton Protective Services for 13 years where he served as Senior Vice President of People Development, Vice President of Customer Support and Corporate Director of Risk Management.

Prior to joining Barton, John was Corporate Director of Security and Safety for an international Data Communications company where he was also asked to lead the company's pursuit of Total Quality. John is former Assistant to the Boston Police Commissioner and served in a variety of civilian and sworn roles. He also served as Security/Safety Manager and Director of Loss Prevention Training for Marshall's Department Stores and in the 1980's developed a wide range of public safety improvement programs for a variety of US cities and the US government.

John currently serves on the Board of Directors of the Georgia International Law Enforcement Exchange (GILEE), the Atlanta Victim Assistance Program (AVA) and is immediate past Chairman of the Greater Atlanta Chapter of the American Society for Industrial Security (ASIS). He is past Chairman and Trustee of the Metropolitan Atlanta Crime Commission. He also serves on the Professional Development Committee of the Atlanta Chapter of the Building Owners and Managers Association (BOMA). In 2007, John was appointed to a Governor's subcommittee on suicide bombing and terrorism awareness, representing the private security industry in the State of Georgia.

John holds a Bachelor's Degree in Criminal Justice with high honors from Northeastern University in Boston, Massachusetts and a Master's Degree in Business Administration, with distinction, from Georgia State University.



TRICIA GIBBS

Tricia Gibbs is the Supervisory Special Agent (SSA) leading the Crisis Management and Special Events Squad at the Atlanta Field Office. SSA Gibbs entered the FBI in 1996 and has worked counterterrorism, criminal, and cyber matters. She was assigned to the Baltimore Field Office for 11 years and was the Senior Supervisory Resident Agent (SSRA) in Delaware. SSA Gibbs served more than 5 years overseas in Hungary, Iraq, Pakistan, and Nigeria.

While assigned to the FBI Academy, SSA Gibbs supervised National Academy (NA) instructors, taught NA leadership courses accredited by the University of Virginia, and instructed tactics to new agent trainees. She is an FBI firearms, tactics, and ALERTT instructor. SSA Gibbs has taught at the International Law Enforcement Academy (ILEA) in Budapest, Hungary and for the Program on Terrorism and Security Studies at the George C. Marshall Center in Garmisch, Germany.

SSA Gibbs received a Master's of Business Administration from the University of Delaware and a Bachelor's of Industrial Engineering from the Georgia Institute of Technology. Prior to the FBI, she served on active duty

in the United States Marine Corps (USMC) and was an engineer in the private sector. She retired from the USMC Reserves as a Lieutenant Colonel.



DR. JAN GORNIAK

Dr. Gorniak is certified by the American Board of Pathology in anatomic and forensic pathology. She served as a Deputy Coroner/Forensic Pathologist for Franklin County, Ohio from July 2005 to January 2008. She is a member of the National Association of Medical Examiners, the International Association of Coroners and Medical Examiners, and the American Academy of Forensic Sciences. Dr. Gorniak is also a registered medicolegal death investigator through the American Board of Medicolegal Death Investigators.

In November of 2008, Dr. Gorniak was elected to the position of Franklin County Coroner, Columbus, Ohio. She was the county's first full-time forensic pathologist coroner. She was re-elected in November 2012, and served in that position until resigning in October 2014. She went on to work as the Deputy Chief Medical Examiner for the District of Columbia (DC) Office of the Chief Medical Examiner. In the Fall of 2016 she was appointed the Fulton County Chief Medical Examiner (Atlanta, GA).

Dr. Gorniak is committed not only to death investigation, but to death prevention, especially in children and young adults. She has spoken out on teen suicide, heroin abuse, infant mortality, and violence as a public health issue.



J.C. "CHRIS" HACKER

J. C. "Chris" Hacker entered on duty with the FBI as a Special Agent in 2000. Following graduation from the FBI Academy, he was assigned to the Jackson Division, where he worked white collar crime, public corruption, and counterintelligence matters. He was also a member of the SWAT team and a firearms instructor. In 2008, Mr. Hacker was promoted to Supervisory Special Agent. In that role, he oversaw the Jackson Division's Counterterrorism, Special Agent Bomb Technician, and Weapons of Mass Destruction (WMD) Programs and led the Joint Terrorism Task Force (JTTF). In 2010, he was promoted to the Counterterrorism Division's (CTD) National JTTF.

In 2013, Mr. Hacker was selected to serve as the Assistant Special Agent in Charge (ASAC) of the Mobile Division's National Security Branch (NSB). The next year he became the ASAC of the Criminal and Administrative Branch.

In 2015, Mr. Hacker was promoted to Section Chief of the NSB at FBIHQ. In that role, he served as the Chief of Staff and Special Assistant for the Executive Assistant Director and oversaw the Executive Staff Section which enhanced the coordination of critical issues affecting the Counterintelligence Division and CTD as well as the WMD Directorate, Terrorist Screening Center and the High Value Interrogation Group.

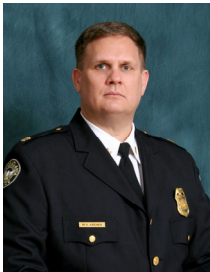

DEPUTY CHIEF SCOTT KREHER

Deputy Chief Scott Kreher began his career 24 years ago as a patrol officer in Zone 3. While a student at Georgia State University, he rode with several officers in Zone 3 and realized law enforcement would be his passion and career choice. After the academy, he chose Zone 3 and worked there during the 1996 Olympics. Later, he became a Field Training Officer.

In 1997, he was transferred to the elite Red Dog Unit to combat street-level drug operations. In 1999, he was promoted to the rank of Investigator and assigned to the Major Fraud Unit. There his duties included criminal investigations of mortgage and identity fraud.

After working Major Fraud, he was promoted to the rank of Sergeant in 2002 where he was assigned as a front-line field supervisor in Zone 5. His duties included supervising patrol officers in the downtown district. It was

soon after his promotion that he was assigned to the Robbery Unit as a supervisor and was responsible for assigning both pedestrian and commercial robbery cases to investigators to complete thorough and detailed investigations for prosecution.

From 2003 through 2005, the Atlanta Police Department transitioned from centralized to decentralized criminal investigations. This moved him to both Zone 1 and Zone 5 Criminal Investigation Units to supervise investigators within those specific commands. From 2005 through 2007, he worked as a supervisor in the Fugitive Unit. This unit included investigators assigned to the Southeast Regional Fugitive Task Force organized by the United States Marshall Service. The unit was responsible for apprehending dangerous felons wanted by the Atlanta Police Department and other jurisdictions identified by the Task Force. In 2007, he went back to Zone 3 as a field supervisor until he was promoted to Lieutenant in 2009. As a new Lieutenant, he was assigned to Zone 4 field operations and commanded both the Morning and Day watch units.

Deputy Chief Kreher was transferred to the Vice Unit in 2011. He was tasked with writing the Standard Operating Procedures for the unit along with implementing new technology utilized for undercover work. He also formed a Hotel Council for the downtown district to address human trafficking and web-based prostitution challenges.

In 2013, he was promoted to Captain and assigned as the Zone 4 Assistant Zone Commander. During his command, he worked to improve community relationships and reduce crime until promoted to Major in 2015 and assigned as the Zone 5 Commander. As the Zone 5 Commander, his team finished 2016 as the Crime Reduction Award winners for APD and continued reducing crime in 2017 until his promotion to Deputy Chief in August of 2017.

Deputy Chief Kreher holds a Bachelor of Science Degree in Criminal Justice from Georgia State University and a Master of Science Degree in Criminal Justice from the University of Cincinnati. DAVID E. WARDELL

David has over 40 years of law enforcement, security management, planning, and operations experience. He spent twenty years as an Army Officer in the Military Police Corps, serving in various capacities in units in the United States, Panama, and Europe. After the military, David joined the Atlanta Committee for the Olympic Games (ACOG) as a Venue Security Manager of the largest multiple event venue for the Centennial Olympic Games.

He worked in the contract security industry as a Branch Manager, Business Development Manager, and as a Security Consultant. David served as a Business Unit Security Manager for the Georgia-Pacific Corporation, responsible for Corporate Headquarters and Aviation Security, as well as Business Unit corporate security support, specializing in the areas of risk assessment and mitigation, executive services and protection, special events, and labor relations.

In his current position, among a varied description of responsibilities, David is responsible for the public safety, cleanliness, infrastructure and quality of life concerns of the 220-Block Atlanta Downtown Improvement District's daily 200,000-population constituency, as well as the convention and tourist visitors (22 million per year).
